In pursuance of CGA's letter No. X-11002/3/2020-EXAM-CGA/1306 dated 19.02.2021. Please find enclosed herewith the result of Departmental Confirmatory Examination held on 28.11.2020. Marks obtained by the candidates have been indicated against their names in Annexure-I.

The marks required for passing in each subject is 40 for General/OBC categories and 35 for SC/ST category candidates. Marks required for exemption is 50 for all categories. Those candidates who have secured 50 marks or more in one subject will be treated as Exempted in that subject. Those who have secured passing marks in both papers shall be treated as passed.

The candidates may please be informed of their results. While communicating the result to the unsuccessful candidates, including Absentees, the consequences, as mentioned in Central Civil Accounts Service (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2010 of not passing the Departmental Confirmatory Examination within the prescribed time may be brought to their notice.

The effective date of grant of increment in the grade shall be governed as per the Central Civil Accounts Service (Accountant and Senior Accountant Group 'C' posts) Recruitment Rules, 2010.
