OFFICE ORDER 27/2022

In terms of DOPT's OM No. 35034/3/2008-Estt (D) dated 19.05.2009 circulated vide CGA's letter No. A-26011/20/ACP/2009/MF.CGA (A)/NGE/343 dated 10.06.2009, the Screening Committee has recommended the Departmental Canteen Staff of CBDT mentioned in the Annexure 'I' for financial upgradation under MACPS as per details mentioned against their names.

The Financial upgradation under the MACP Scheme shall be purely personal to the employee and shall have no relevance to his seniority position. There shall be no additional financial upgradation for the senior employees on the ground that the junior employee in the grade has got higher grade pay under the MACP Scheme. No stepping up of pay in the Pay band or Grade pay would be admissible with regard to Junior getting more pay than the Senior on account of Pay fixation under MACP Scheme.

On upgradation under the MACP Scheme, the officials may exercise an option under the provision of FR 22(1) (a) (1) to get pay fixed in the higher grade pay either from the date of their upgradation or from the date of their next increment viz. 1st July of the year in accordance with clarification No.2 of Department of Expenditure OM No. 1/12008-1C dated 13.09.2008. The option must be exercised within a period of one month. The option once exercised shall be final.

There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be available.

All other conditions for grant of financial upgradation under the MACP Scheme, as laid down in DOPT's OM No. 35034/3/2008-Estt-(D) dated 19.05.2009 should be strictly followed.

This issues with the approval of Competent Authority.
